








A Defining Moment: The Cancun Accords



1996


• Meeting held in Cancun resulting in the so-called Cancun Accords, which incorporated key points of the WCO's Immediate Release Guidelines as goals for regional customs authorities



1998

• Cancun II – follow up meeting with regional customs authorities held in Santiago, Chile. The customs best practice recommedations in the Cancun Accords serve as CLADEC's main advocacy goals for many years.

Expanding Our Influence: 2002–2008



- CLADEC closes the Panamanian Corporation due to a new government requirement that corporation directors all reside in the country.
- CLADEC establishes a not-for-profit corporation in the United States in the State of **Florida**.
- New and updated by-laws are written and approved. This
- includes, for the first time, an anti-corruption clause.

Expanding Our Influence: 2002–2008



2002-2008

CLADEC actively supports passage of key **free trade agreements** during this period. This support involved considerable activity, including lobbying in the U.S. Congress and in the various countries in our region.

2008 - 2013

CLADEC was an early advocate of the concept of trade facilitation, participating in numerous regional forae, incuding several sponsored by the WCO focused on informing regional customs authorities about the concept.

The successful negotiation of the World Trade Organization's Trade Facilitation Agreement (TFA) gives CLADEC a new and more powerful advocacy focus.




Responding to the Pandemic: (2020 - 2021)
